### HOLD HARMLESS RELEASE FORM

In consideration of being allowed to enter into and use the Munroe Center for the Arts ("Munroe") facilities/building, and to participate in any of the Munroe programs, related events, camps, schools, studios and grounds, the undersigned acknowledges, appreciates and agrees that:

1. The risk of injury from any activities involved in this facility/building is possible, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest staff member immediately; and,

I further acknowledge and agree that in choosing to enter into and use the Munroe facility, and engage in any activities, I recognize and accept that because the Munroe facility is open for use by many other individuals, I am at a higher risk of exposure to and/or contracting COVID-19 or other diseases such as influenza or Legionnaires Disease; and,
5. KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, and assume full responsibility for all such risks; and,
